# 3. ADMINISTRATIVE ACCEPTANCE

- 3.1. Online registration is open at www.drifting.cz from 26/09/2022 to 20/10/2022. Riders who have registered online must attend the administrative check-in on the day of the race.
  3.2. The administrative handover will be defined within the time schedule of the plant in the

- secretariat area.

  3.3. During the administrative check-in, the rider must:

   Sign a declaration to participate in the race (available on site).

   Proof of a racing license, if the driver applied for it by 26/09/2022. Foreign drivers must supply a year-round racing license from their country.

   Pay the entry fee based on the championship or cup selected during the administrative takeover.

   Information about your service vehicle and its license plate to gain access.

   Sign a declaration to natricinate in the rare (available on site).

  By signing the entry form, the driver agrees to have read and understood the CDS Sporting Code, the 2022 Drift Sporting Regulations, the regulations for this event and agrees to abide by the rules set out in these documents. The driver understands and agrees that the competition is filmed and photographs may be taken of the driver with the racing car and these materials may be used on social media.

  3.4. On the day of the race, a the administrative reception, it will be possible to purchase:

  After running out of wristbands as part of the entry fee, additional wristbands (entrances) at a discounted price of CZX 150, but a maximum of 5 pcs.

  3.5. At the administrative check-in, the rider will receive:

  3.5.1 starting numbers and obligatory advertisements of the organizer, which the rider cannot refuse. Violation of this rule will result in a fine equal to the entry fee.

  3.5.2 the official sticker layout guide for the show car, where each sticker needs to be applied to a race car. If there is a conflict with the sponsor stickers of a particular rider, the problem must be consulted with the organizer in advance so that it can be resolved.

  3.5.3. Entry card for a service vehicle.

# 4. CONDITIONS OF PARTICIPATION

- 4.1. The following riders can participate in the event:
   license of the Autoklub CR issued for the PRO / PRO 2 group.
   license issued by the car club from the driver's country for groups PRO / PRO2.
  4.2 Drivers may enter the event with any rear-wheel drive car that complies with the relevant class rules as set out in the technical regulations prepared by the CDS Technical
- relevant class rules as set out in the technical regulations prepared by the CDS Technical Committee for each class for 2022.

  4.3. Anti-doping restrictions

  4.3.1. During the event, the driver must not be under the influence of alcohol, drugs or other intoxicating substances. The driver must not have any health problems that would affect his ability to drive.

  4.3.2. Violation of this rule will result in disqualification or disqualification from the race with the carefullation of any points already received during the race and the carefullation of the

- driver's drift card.

  4.3.3 According to the World Anti-Doping Code and FIA rules, it is allowed to have alcohol and doping control during the race. Alcohol can be checked by the event organizer using a breathalyzer. The limit of the breath test is 0. If the breath test proves the alcohol content in the driver's breath, the driver is excluded or disqualified from the event according to point 4.5.
- 5.1. During the event, compulsory liability and car accident insurance do not apply
- 6. TECHNICAL ACCEPTANCE

  6.2. During technical acceptance, the driver must present the following documents:

   FIA or ASN (Auto Club of the Czech Republic) motor sports license, if any,

  sports license, where the chief technical commissioner indicates whether the racing car is allowed to participate in the event.

  6.3. The official stickers received at the administrative scrutineering Starting numbers, drift manufacture coractinger's disease.
- 6.3. The official stickers received at the administrative scrutineering Starting numbers, drift emblems and mandatory organizers' advertisements must be affixed to the car in the layout shown in the official sticker placement guide available at the secretariaty prior to the technical scrutineering.

  6.4 The safety equipment of the driver is checked during the technical acceptance. The marshals have the right to check the rider's safety equipment at any time during the race.

  6.5. The maximum permissible noise level of the PRO group is 10.2 dB and the PRO 2 group is 98 dB (A) at 3500 rpm (+3 dB (A) permissible error), which is checked based on the sound measurement method at a distance of 500 mm and in 45 degrees from the exhaust pipe.

  6.6. Max tire width: PRO 265mm and PRO 2 235mm tires must have an E homologation mark.

7.2. During training, the rider must follow the rules, where he rides as the leading rider in the first race and as the chasing rider in the next. It is kindly forbidden to overtake or go around the queue waiting for training.
8. RACE

8.1. The drift competition in each class consists of 2 parts:

• Qualifying rides,

• tandem or elimination rides.

8.2. The starting of the car, for both parts of the race (qualification and tandem driving), is controlled by the marshal at the end of the starting zone, the command to start will be given using the starting traffic light. This command must be perceived as a start command.

Qualifying rides

8.3. Qualifying races are run according to the starting list, which will be published on whatsapp communication or on the official notice board in the discussion area. Once everyone has completed the first run, a series of second runs will begin.

8.4. Riders must be aware that they must be on the grid at the time of their qualifying run, otherwise the will receive a zero score if they do not take part in their run.

8.5. In the event that a rider is unable to take part in a qualifying run, the matter must be moved to the end of the relevant series of qualifying runs. If a race official is not notified that a driver cannot participate in a qualifying run, the driver will be awarded a grade of 0 (zero) for that particular run. for that particular run. 8.6. Based on the best qualifying run, the TOP16 or TOP32 riders for each class qualify for tandem runs.
8.7. If the number of riders is insufficient, the Chief Sports Commissioner can decide whether to use the ranked TOP8 or TOP4.
8.8. In each tandem or elimination class, riders are split into pairs, with each pair completing two runs, with one rider leading (rider in front) in the first run and the other rider leading the second run. The best driver of the pair, as judged by the judges after both runs, advances to the next round. to the next round.  $8.9.\ Tandem\ rides\ are\ judged\ according\ to\ the\ evaluation\ principles\ described\ in\ the\ sports$

Discussions for riders

8.10. Discussions for riders are mandatory for all participants. Riders must be aware of when
they must participate in the debate based on the race time schedule. Penalty for breaking
this rule - he will be penalized and may be disqualified from the race. This ban is given to
drivers who do not attend the debate after receiving an invitation from a race official.
8.11. A rider who misses a rider's debate cannot file a protest.
8.12. Drivers take full responsibility for their passengers and the safety of their team.

- 9.1. During the event, riders are not allowed to drift outside the designated track on the territory of the racetrack.

  9.2. During the event, it is strictly forbidden to drift on the way to the start zone or after the finish line. Offenses will be punished according to the CDS sports regulations for 2022.

  9.3. Burnout on site is strictly prohibited.

  9.4. Drivers are not allowed to drift outside of their rides with the following exceptions:

   For up to 10 seconds after announcing the results of his/her tandem ride.

   After the winner of the final battle is declared, both drivers have a burnout time of their choice as long as their tires last. If the layout of the track allows it, other riders can also join. At the driver briefing, the drivers will be informed about the drifting rules after the final hattle.
- 9.5. During the event, each rider is fully responsible for their actions on the track and for their own safety and that of others.
- their own safety and that of others.

  9.6. During the event, on the territory of the track leading from the service parking lot to the starting zone, the driver bears full responsibility for any accidents with people that may occur on the track. It is not recommended to drive faster than 40 km/h from the service parking lot to the starting zone. If the driver is caught at a higher speed or drifts from the service parking lot to the starting zone, the drift organizer can impose a fine of CZK 5,000.

  9.7. During the event, it is recommended to use radio communication between the rider and the team representative by choosing a frequency that is not used by the event organizers, security and stewards.

  9.8. During the competition, the Participants, their representatives, team mechanics or their relatives of not have the right to hehave aggressively (shout, swear, excitualate or otherwise
- relatives do not have the right to behave aggressively (shout, swear, gesticulate or otherwise insult or threaten the track referees or the organizer's employees). Such behavior will be interpreted as unsportsmanlike conduct, for which there is a risk of a fine of 5,000 CZK. Next in addition, participation in the competition is subject to a warning, and in case of repeated unsportsmanlike behavior, the Participant may be excluded from the competition, as well as the information is forwarded to the Participant's ASN for assessment of exclusion from the
- Championship.

  9.9. On the individual tracks, participants must comply with the noise restrictions specified in each competition regulation, which were announced in advance by the organizer of the respective stage. The driver must be able to modify his racing car to meet the given limits.

  9.10. Drifting, tire spinning, burnout, etc. are strictly prohibited. Drifting elements after the official end of the competition in the park for participants, as well as on other parts of the track, trailer stands, exit points of the track and roads are strictly prohibited. The rule applies as long as the riders are in the track area. For such an offense, the driver will be punished associated by the descript of the drifts on exiting from the consection. separately by the decision of the drift commission from the competitions that took place and the cancellation of the points obtained in them, as well as a possible fine.   9.11. The following actions of the driver will be considered unsportsmanlike behavior and disrespect for the rules in general and will result in a fine of up to CZX 10,000 and/or exclusion from the race:

  any aggression or public expressions of dissatisfaction with decisions made by referees and sports commissioners,

- any gesticulation towards sports commissioners or referees,
- delaying the race,
- any intervention and disruption of the work of referees and sports commissioners,
   any attempt to persuade the referees/stewards to change their decision against a particular rider.

### 9.12. CODE, Behavior and Conduct :

9.12. CODE, Behavior and Conduct:

- The organizer reserves the right to breathalyze a competitor at any time without prior notice and at its own expense. Prescription drugs used by the rider on a doctor's recommendation must be stated by the rider upon receipt. No disturbance at night from 10.00 p.m. to 7:00 a.m. The code of conduct is binding for all competitors not only during a sports competition, but also during press conferences, public appearances or promotional events related to the race. Riders, respectively entire teams are required to participate in promotional events of the competition according to their possibilities. The rider is responsible for the behavior and appearance of the team and their guests. Professional behavior is binding for riders, or for teams. Teams must maintain professional behavior and safety at all times or negligent or knowing voludations of safety principles of any kind will not be tolerated. Competitors will leave their station clean, tidy and free of waste (including tires) after the end of the sporting event.

  9.13. During practice, qualifying and tandem rides, riders must comply with the following safety rules:
- drivers must wear seat belts. Penalty for violation of this rule prohibition of participation
- in the ride.

   riders must wear a helmet with buckle on. Penalty for violation of this rule prohibition of participation in the ride.

  only the driver can be in the car (unless the organizer and the chief sports commissioner, at the request of the driver, have allowed the possibility of a passenger in the car during

   The suit must comply with the rules described in the technical regulations of each class.

- 10.1. The depot will be located on the territory of the track, where only racing and service
- 10.1. The depot will be located on the territory of the track, where only racing and service cars are allowed to enter.
  10.2. The maximum permitted speed in the depot is 10 km/h. First time speeding may be penalized with a warning or a fine, but if any driver or driver representative repeatedly breaks this rule with a race and/or service car, they will not be allowed to enter the pit.
  10.3. Repairs, refueling and tire changing are only allowed in the depot.
  10.4. The driver and his team are responsible for compliance with occupational safety and fire safety rules.
  10.5. If the racing car is standing on asphalt, a tarpaulin must be used under it.
  Conditions for the driver's service box

If refueling takes place in the driver's service box, the box must be equipped with a fire extinguisher for a maximum of 2 racing cars, a minimum of 4 kg, valid for the duration of the race and the fire extinguisher must be usable for the fuel used by the particular racing car.

### 11. RESULTS

- 11.1. The preliminary results of the drift competition will be published on the drifting.cz website and in the WhatsApp communication to the race or on the official information board in the discussion area.

  11.2. The official results of the drift competition will be announced on 25/09/2022 and will be published on the website www.drifting.cz

### 12. RESULTS

- 12.1. The ceremonial announcement will take place on the track area after the Tandem rides  $\,$

  12.2. The organizer and sponsors have the right to award prizes to other riders of their choice.

  12.3. The TOP 3 riders must attend the award ceremony. Drivers who do not attend the ceremony lose their right to receive prizes.

  12.4. PRO and PRO2 class riders must attend the awards ceremony in their racing overalls.

  12.5. No drifting or rowing is allowed after the awards ceremony due to noise restrictions, unless given permission by a race official.

### 13. PROTESTS

- 13.1. Protests about a racing car not meeting the technical regulations can only be submitted to the race director during the event. The time schedule of the event is given in the propositions.

  13.2. Penalties that were not mentioned in the regulations for the event or the season will be determined based on Chapter 12 of the General Rules of the SPORTING CODE OF THE CZECH REPUBLIC OR CZECH DRIFT SRIES.

  13.3. The adjudication and adjudication process for each protest will be decided by the stewards and communicated to all parties involved in the protest.
